

SOWDIV SCCA - Annual Meeting Angleton, TX - January 12, 2019

Corporation President Cathy Barnard called the 2019 Annual meeting of the Southwest Division SCCA to order at 10:01 AM. We had 39 persons in attendance. We had a roundtable discussion at the end of the meeting.

Vince Hummer, Treasurer Report

Submitted SCCA SOWDIV Dec 31, 2018 Financial Statement Money in bank, positive year.

Motion made by John Lieberman; second by Larry Svaton. Unanimous approval.

A discussion was <u>started</u> regarding how to best utilize existing funds in checking account, including funding some expenses that had not been able to be funded in the past. (See "new Business" for more). More discussion was tabled for future review.

COMMITTEE REPORTS:

Peter Lindberg, Divisional Coordinator SOLO Group

Peter is currently working with those he knows but still trying to get in touch with the regions that are not showing any interest in being involved. However, since our Division is so large, it was not financially feasible for him to do so. He requested funds to help and that is reflected in the 2019 budget (included at the end of these minutes)

Richard Tomlin (on behalf of Rally Group)

Still building the Rally Group and they are having some success with the budding Time Trials that they are working on building up. Best success is when they are paired with a Road Race. Will have more data next year.

Larry Svaton (on behalf of Road Racing) Robey Clark, Road Racing No class or group changes.

A change will be made to the 2019 SWRRC rules that removes sentence 2 from Section 6 (see updated rules at the end of these minutes) to clarify what will be the "last race of the year". Since this decision changes a document that has already been published, a vote needed to be taken. Motion made by Bob Neff; second by Larry Svaton. There were 2 voting members "against" the decision, and 5 voting members "for" the decision. Therefore, the motion was carried with a majority vote.

Diane Carter, Timing and Scoring

Everything is going along solidly and Diane commends Texas Region on gathering a group of people that have been able to learn the T&S system so they can handle their own races without her having to travel to each one.

RALLY CROSS:

Mike Jiang was present and gave us an update; the first in many years. He informed the Board that the Rally Cross Steward of Record (Damon Guy Cuccia) had not been involved in more than 5 years and that he was the only one that was trying to grow the Rally Cross program throughout the whole state. He stated he didn't know how much longer he could do it alone and requested that the crowd reach out to anyone that might be interested in helping him.

OLD BUSINESS:

2018 Points allocation – this was discussed at the October scheduling meeting but voted on by email since we did not have a quorum at that meeting.

It was decided, by email, that the first race on Sunday, Sept 2, at MSR Houston, was the last race used to calculate points (double) and close out the 2018 SOWDIV race season. This was in an attempt to clear up any confusion since the "last race" that had previously been scheduled at Eagles Canyon was canceled.

2019 Points allocation: see Road Racing Report above

NEW BUSINESS:

- 1) SOWDIV President Cathy Barnard reviewed current DA positions (listed above under her report) and a few are looking for replacements.
- 2) 2019 Budget: See 2019 budget (labeled "estimated") at the end of these minutes. The items in orange are actual approved budgeted items and the items in yellow are normal year-to-year operating expenses. The income column is based on previous years events and is only an estimate.

Motion by Bob Neff; second by Jerry Wannarka. Unanimous approval.

- 3) It was generally discussed that only the Annual Meeting would be held publicly from now on. All other meetings will attempt to be held under the category of "special meetings" (email and/or telephone conference) to save people time and money. The next Annual Meeting will be held in the Texas Region; time and date to be confirmed by RE Matt Lucas.
- 4) It was generally discussed that a committee be formed to start working towards a goal of having a "SOWDIV Convention" every year. Possibly a one/two day meeting that would include all areas of expertise (training, getting to know what each entail, etc) that would also be a fun event and possibly bring in new members and/or get current members involved in a specialty. Rosa Lee Smart volunteered to head up this committee.
- 5) Bylaws Revisions were presented to the Board. Although there was a discussion at the September 2018 Scheduling meeting that the 30-year-old Bylaws did need an update, notice was not sent out by the Secretary with the proposed changes until January 3, 2019.
 - a) According to the current Bylaws (Article XII), if the Bylaws are to be altered, amended or repealed, the Directors must be given 30 days written notice. Area Director Dan Helman tabled the discussion and requested that, when the 30 days have passed, that any Bylaw discussion occur only between the Board members. The Board members (and/or proxies) that were present at the Annual Meeting will again receive the proposed changes on or after February 3, 2019 and discussion will commence either by email and/or phone conference. A "special meeting" will then be convened, by email, for a vote.

The 2018 Tony Predock Award was presented to Texas Region outgoing RE Bob Neff for his support, drive, loyalty and build-up of his Region and for his overall support to the Southwest Division.
